Synopsis

There is limited information available concerning the fishery of Bird Lake. It supported a native brook trout population and supplemental stocking occurred for a short period in the 1940's and 50's. One letter from 1972 relates that they were 'plentiful' at one time. With the development of the lake, the population declined and largemouth bass were stocked. No assessment has been done since the bass introduction, but it is believed that a self-sustaining population is present, and that the brook trout are probably extirpated. It is possible that other species, such as smallmouth or rock bass have become established via illegal stocking.
